FOOD VENDOR POLICY:

Persons permitted and licensed to operate a VENDING CART OR MOTORIZED MOBILE CONCESSION pursuant to this application shall:

- Comply with the provisions of all Federal and Province of Ontario laws, City by-laws and other applicable regulations and the requirements of the Chief Building Official, the Fire Department and the Medical Officer of Health.
- Use only manually propelled vehicles having dimensions no larger than 3' x 6', for which the City Clerk shall provide a licence.
- The City licence may be required by the licensee.
- Provide said equipment with a refuse container.
- Sell / offer only the products and/or services specified and approved.
- Be neat, wear clean apparel and operate with proper hygiene practices and practise good customer service principles.
- Conduct business only within the space allocated.
- Do not use any loudspeaker, amplifier, hailing device or music player.
- Clean up any debris from the site throughout each day as required and upon the conclusion of daily business.

- ❑ Remove the vending cart, garbage container and debris from the site each day upon the conclusion of business.
- ❑ Payment is due in advance of vending.
